Statement of the Participant in the Qualifying Course of the Formula BMW Talent Cup on the exclusion of liability

Responsibility of Participants

The Participants take part in the Course at their own risk. They bear the sole responsibility under civil and criminal law for all damage caused by them or the vehicle used, insofar as the following liability exclusion is not applicable.

Liability waiver

By submitting their entry drivers and their legal representatives declare that they waive any claim whatsoever to compensation for damages that arise in connection with the Course, against

- the FIA, its Presidents, Boards of Management, Managing Directors, Secretary Generals, employees and other organs
- BMW AG, BMW Motorsport, mpb communications GmbH & Co. KG, MYGALE S.A.R.L. its Presidents, Boards of Management, Managing Directors, Secretary Generals and employees
- the organiser, marshals and assistants, race track owners
- authorities, racing services and all other persons who are connected with the organisation of the Course,
- the road construction authorities insofar as any damage or injury is caused by the condition of the roads during the Course and any accessories or road furniture, and
- the agents and employees of all the persons and entities referred to above, apart from damages resulting from injury to life, to the body or to health arising from an intentional or negligent breach of duty – also on the part of a legal representative or an agent of the group of people released from liability, and apart from other damages that result from an intentional or grossly negligent breach of duty – also on the part of a legal representative or an agent of the group of people released from liability.

And

- the other Participants (competitors, drivers, co-drivers), their assistants, owners and keepers of the other vehicles,
- the own competitors, the own driver, co-driver (any other special agreements between the owners, keepers, competitors, drivers, co-drivers take priority) and their own assistants that arises in connection with the Course (untimed and timed training, warm-up, racing) apart from damages resulting from injury to life, to the body or to health arising from an intentional or negligent breach of duty – also on the part of a representative or agent of the group of people released from liability – and apart from any other damages that result from intentional or grossly negligent breach of duty – also on the part of a legal representative or an agent of the group of people released from liability.

The liability exclusion shall be applicable to any claims based on any legal grounds whatsoever, in particular to claims for damages arising from contractual or non-contractual liability and for claims arising from illegal actions. Implied liability exclusions shall not be affected by the above liability exclusion clause.
